**S.O. 1577(E).**— In exercise of the powers conferred by sub-clause (b) of clause (46A) of section 10 of the Income-tax Act, 1961 (43 of 1961), (hereinafter referred to as “the Income-tax Act”), the Central Government hereby notifies the Patiala Urban Planning And Development Authority (PDA) [AAALP0095J] (hereinafter referred to as “the assessee”), an authority constituted under the Punjab Regional and Town Planning and Development Act, 1995 (Act 11 of 1995), for the purposes of the said clause.

This notification shall be effective from the assessment year 2024-25, subject to the condition that the assessee continues to be an authority constituted the Punjab Regional and Town Planning and Development Act, 1995 (Act 11 of 1995) with one or more of the purposes specified in sub-clause (a) of clause (46A) of section 10 of the Income-tax Act.
